

## **Application Process**

Due to the competitive nature of the BTIG summer internship program, candidates are encouraged to include outside interests, personal attributes, and relevant references that can distinguish themselves as an applicant.



## **KEY ELEMENTS FOR CONSIDERATION:**

- The ideal candidate will be enthusiastic, diligent, ambitious, entrepreneurial, and confident but with a team player mentality.
- We look for candidates who are flexible and willing to engage with the task at hand, whilst being adept at multi-tasking in a challenging environment.
- You should have the ability to interact with all levels of the organization and have excellent communication skills alongside a strong attention for detail.
- All applicants should be currently enrolled in a Bachelor's or Master's degree programme and preferably due to graduate between May 2023 and August 2024.
- A financial degree is not required but the candidate should be able to demonstrate an interest in the financial markets.
- Interns are required to work for nine consecutive weeks (vacation time must be scheduled around the internship program).
- All interns undergo the same background check process as BTIG employees.
- Applicants may be contacted by a BTIG representative if more information is required.

The internship program will begin on 3<sup>rd</sup> July 2023 and end on 1<sup>st</sup> September 2023.
