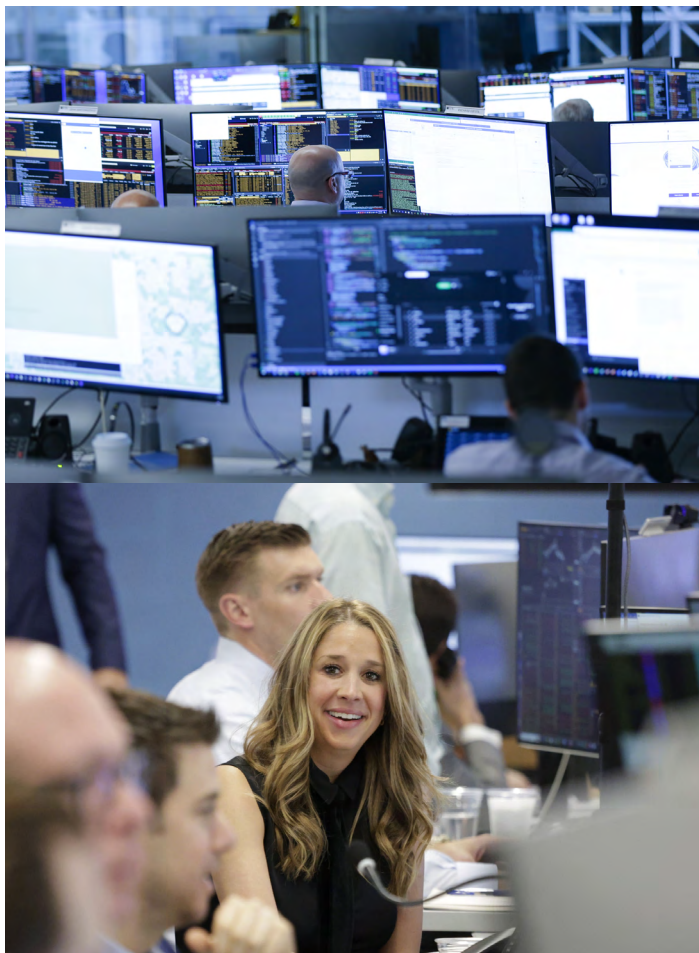

Application Process



Due to the competitive nature of the BTIG summer internship program, candidates are encouraged to include outside interests, personal attributes, and relevant references that can distinguish themselves as an applicant.



KEY ELEMENTS FOR CONSIDERATION:

- All candidates must complete the application, even if the firm has already received their resume or other indication of interest.
- Candidates will only be considered for a position after they complete the application and provide their resume.
- All applicants must have completed at least three years of undergraduate coursework, work experience or military service.
- Interns are required to work for eight consecutive weeks (vacation time must be scheduled around the internship program).
- All interns undergo the same background check process as BTIG employees.
- Applicants may be contacted by a BTIG representative if more information is required.
